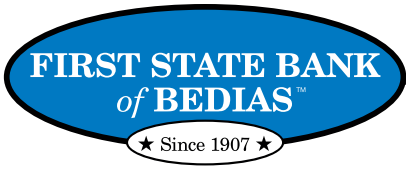

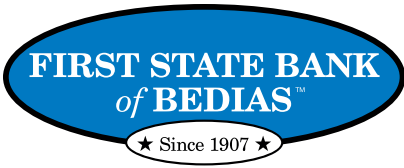

How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information, the reasons First State Bank of Bedias chooses to share, and whether you can limit this sharing.

Definitions

Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. <i>First State Bank of Bedias has no affiliates.</i>
Nonaffiliates	Companies not related by common ownership or control. They can be financial or non-financial companies. <i>First State Bank of Bedias does not share with nonaffiliates so they can market to you.</i>
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products and services to you. <i>First State Bank of Bedias doesn't jointly market.</i>
